## RESOLUTION RECOMMENDING THE DISPOSAL OF UNSERVICEABLE PROPERTIES /OLD RECORDS

WHEREAS, the Disposal Committee of the Philippine Consulate General in Chicago (Chicago PCG) recommends the disposal of its unserviceable properties stored at the Consulate's premises, as listed in Post's Inventory and Inspection Report of Unserviceable Semi-Expendable Property (IIRUSP), in accordance with existing rules and regulations on the disposal of unserviceable properties;

**WHEREAS**, the disposal of worn and defective properties will enable Post to free up its limited space/storage area for more productive use;

**WHEREAS**, Chicago PCG has been authorized to dispose of said unserviceable properties by Destruction/Throwing, per OAMSS-PSSD-2023-04-013 dated 18 April 2023 with the approval of the Acting Undersecretary for Administration;

WHEREAS, Republic Act 9184 and its Implementing Rules and Regulations (IRR) as well as the Government Procurement Policy Board (GPPB) Resolution No. 28-2017 dated 31 July 2017 prescribe the rules and procedures to be followed by entities in their procurement activities;

**WHEREAS**, the GPPB Resolution No. 28-2017 provide the guidelines for the procurement of goods and services, infrastructure projects and consulting services to be procured and performed overseas;

**WHEREAS**, the disposal of the unserviceable properties is included in Chicago PCG's Supplemental Project Procurement Management Plan for Calendar Year 2023;

**WHEREAS**, pursuant to GPPB Resolution No. 28-2017, the Consulate, through its Bids and Awards Committee (BAC), solicited Request for Quotations (RFQ) from selected reputable companies and obtained the following quotations:

NOW, THEREFORE, foregoing premises considered, the Chicago PCG's BAC unanimously resolved to recommend to the Head of Procuring Entity the procurement of the services of Junk Relief, which submitted the lowest calculated and most responsive quotation in the amount of US\$375.00, in the disposal of the unserviceable properties, subject to existing accounting and auditing rules and regulations.
