RESOLUTION RECOMMENDING THE PROCUREMENT OF CATERING SERVICE FOR THE VIP TOUR LAUNCH ATTENDEES AND PARTICIPANTS - CULTURAL SECTION

WHEREAS, the Philippine Consulate General in Chicago (Chicago PCG), intends to procure a food catering service for the attendees and participants in the VIP Tour Launch which will be held on 16 February 2024 at the 2nd floor of the National Louis University (122 S Michigan Ave Chicago 60603), the procurement of which is included in Chicago PCG's Project Procurement Management Plan for FY 2024;

WHEREAS, Chicago PCG intends to procure a food catering service with the following terms of reference:

- a. Seventy five (75) orders of lunch bento box
- b. With rice, three Filipino (3) dishes and dessert
- c. Payment terms

WHEREAS, Republic Act 9184 and its Implementing Rules and Regulations (IRR) as well as the Government Procurement Policy Board (GPPB) Resolution No. 28-2017 dated 31 July 2017 prescribe the rules and procedures to be followed by entities in their procurement activities;

WHEREAS, the GPPB Resolution No. 28-2017 provided the guidelines for the procurement of goods and services, infrastructure projects and consulting services to be procured and performed overseas;

WHEREAS, the GPPB Resolution No. 28-2017 dispenses with the requirement for Foreign Service Posts (FSP's) to post their procurement activities in the PHILGEPS website until the corresponding facility has become available through the PHILGEPS modernization project;

WHEREAS, the procurement of said POS system is included in Chicago PCG's Supplemental Project Procurement Management Plan for Calendar Year 2024;

WHEREAS, pursuant to GPPB Resolution No. 28-2017, the Consulate, through its Bids and Awards Committee (BAC), solicited Request for Quotations (RFQ) from selected reputable companies and obtained the following quotations;

WHEREAS, upon evaluation of the BAC, *Tita Mia's Filipino Restaurant & Cafe* submitted the lowest calculated and most responsive quotation in the amount of One Thousand and Two Hundred Forty Eight US Dollars (USD 1,248.00);

NOW, THEREFORE, foregoing premises considered, Chicago PCG's BAC unanimously resolved to recommend to the Consul General and Head of Procuring Entity the procurement of the food catering service from *Tita Mia's Filipino Restaurant & Cafe* in the amount of USD 1,248.00, subject to existing accounting and auditing rules and regulations.
