RESOLUTION RECOMMENDING THE PROCUREMENT OF INTEL CPU FOR THE USE OF THE CONSULATE GENERAL OF THE PHILIPPINES IN CHICAGO – VISA SECTION

WHEREAS, the Philippine Consulate General in Chicago (Chicago PCG), intends to replace the existing outdated intel CPU of Chicago PCG – Visa Section;

WHEREAS, Chicago PCG intends to procure one (1) unit of intel CPU with 16 GB memory, 512 GB SSD storage, 12th Generation Intel Core i5 processor, and 3-in-1 memory card reader;

WHEREAS, Republic Act 9184 and its Implementing Rules and Regulations (IRR) as well as the Government Procurement Policy Board (GPPB) Resolution No. 28-2017 dated 31 July 2017 prescribe the rules and procedures to be followed by entities in their procurement activities;

WHEREAS, the GPPB Resolution No. 28-2017 provided the guidelines for the procurement of goods and services, infrastructure projects and consulting services to be procured and performed overseas;

WHEREAS, the GPPB Resolution No. 28-2017 dispenses with the requirement for Foreign Service Posts (FSP's) to post their procurement activities in the PHILGEPS website until the corresponding facility has become available through the PHILGEPS modernization project;

WHEREAS, the procurement of said unit of intel CPU is included in Chicago PCG's Supplemental Project Procurement Management Plan for Calendar Year 2023;

WHEREAS, pursuant to GPPB Resolution No. 28-2017, the Consulate, through its Bids and Awards Committee (BAC), solicited Request for Quotations (RFQ) from selected reputable companies and obtained the following quotations;

WHEREAS, upon evaluation of the BAC, Micro Center Chicago, submitted the lowest calculated and most responsive quotation in the amount of Six Hundred Ninety-Nine & 99/100 Dollars (USD699.99);

NOW, THEREFORE, foregoing premises considered, Chicago PCG's BAC unanimously resolved to recommend to the Consul General and Head of Procuring Entity the procurement of one (1) unit of intel CPU from Micro Center Chicago in the amount of USD699.99, subject to existing accounting and auditing rules and regulations.
