### BAC-Resolution No. 13-2023

#### RESOLUTION RECOMMENDING THE PROCUREMENT OF ONE (1) SET OF SOFA AND LOVESEAT FOR THE USE OF THE CONSULATE GENERAL OF THE PHILIPPINES, CHICAGO

**WHEREAS**, the Philippine Consulate General intends to replace the existing worn-out sofa at the reception area of the Consulate and is also included on the list of unserviceable properties for disposal. The said sofa is being used by the Consulate for 11 years already;

**WHEREAS**, Chicago PCG intends to procure one (1) set of sofa and loveseat which can accommodate 2 to 6 people;

**WHEREAS**, Republic Act 9184 and its Implementing Rules and Regulations (IRR) as well as the Government Procurement Policy Board (GPPB) Resolution No. 28-2017 dated 31 July 2017 prescribe the rules and procedures to be followed by entities in their procurement activities;

**WHEREAS**, the GPPB Resolution No. 28-2017 provide the guidelines for the procurement of goods and services, infrastructure projects and consulting services to be procured and performed overseas;

**WHEREAS**, the GPPB Resolution No. 28-2017 dispenses with the requirement for Foreign Service Posts (FSP's) to post their procurement activities in the PHILGEPS website until the corresponding facility has become available through the PHILGEPS modernization project;

**WHEREAS**, pursuant to GPPB Resolution No. 28-2017, the Consulate, through its Bids and Awards Committee (BAC), solicited Request for Quotations (RFQ) from selected reputable companies and obtained the following quotations:



**NOW, THEREFORE**, foregoing premises considered, the BAC of the Philippine Consulate General in Chicago unanimously resolved to recommend to the Consul General and Head of the Procuring Entity the procurement of one (1) set of sofa and loveseat from Bob's Furniture, which submitted the lowest calculated and most responsive quotation in the amount of \$848.99, subject to existing accounting rules and regulations.
