- 5. Your quotation should include the costs for the following, among others, involving the property at 945 Timberhill Road, Highland Park, Illinois:
 - The company must be able to undertake the following:
 - Conduct interior and exterior pest control inspection.
 - Identify the right treatment to eliminate pest problems and keep it from coming back
 - Use of non-toxic, environment-friendly pest treatments
 - Guarantee of 30 days. If pests come back within 30 days of treatment, company will treat remaining pests at no additional cost.
 - The company must be able to finish the cleaning by 30 January 2025.
